Documentation Required for Infusion Care Setup

- Patient name & date of birth
- Patient phone number & email
- Patient insurance (front & back copies of cards)
- Patient diagnosis
- Has the patient ever been on an infusion/biologic before?
 - If yes, which medication?
 - Authorization/referral # of previous medication
- Referring doctor
- Referring doctor phone & fax number
- Name of medication prescribed for infusion
- Prescription or order for infusion medication
- Doctor's visit notes, infusion records, hospital discharge instructions (most recent three (3) months if possible)
